

Fair Rents (Scotland) Bill

Introduction

A proposal for a Bill to protect private sector tenants by introducing measures to limit rent increases and to increase the availability of information about rent levels. The consultation runs from 15 May 2019 to 6 August 2019. All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. However, the option also exists of sending in a separate response (in hard copy or by other electronic means such as e-mail), and details of how to do so are included in the member's consultation document. Access to affordable housing would be beneficial for these protected characteristics who currently are disproportionately suffer from unaffordable housing. For example, Glasgow's transgender community have effectively "ghettoised" in the city's southside due to the more affordable rents. Because transgender people are discriminated against in employment, they do not have the same income that can be dedicated to housing as their cisgender (not-transgender) counterparts. The result of this "ghettoisation" is that transgender people have been largely forced to live in areas where they can afford it, rather than being able to choose where to live based on factors such as proximity to their place of work, or even their personal safety. I believe that this is true for most protected characteristics.
